





## 2022 Performance Medication Adherence for Cholesterol for Hispanic vs. White Members






## 2022 Performance for A1c Control for Hispanic vs. White Members

### Why Managing these Measures Matters

Flu vaccination is associated with a lower mortality from all causes, stroke, chronic renal disease, DM, pneumonia, COPD, heart diseases and malignancy (Wang et al. 2007)

A 1% increase in A1c level among patients with type 2 diabetes is associated with an increase in allcause mortality, heart disease, heart failure, stroke and peripheral vascular disease (Zhang et al. 2012)

Higher levels of HbA1c is associated with an increased risk of stroke with a dose-dependent response when compared with patients with HbA1c <9%, even after adjusting for CHA2DS2-Vasc risk factors and use of oral anticoagulants. (Kerzele et al. 2022)

Poor statin adherence is associated with increased risk of cancer and cardiovascular mortality (Lee et al. 2020)



#### **Best Practices**



- Diabetes self management education program led by diabetic educators
- Pharmacist led diabetic clinic with collaborative practice agreement
- Customized outreach and mailers
- Group classes led by health coaches/diabetic educators/nurses

#### **Cholesterol Management** Programs

- Weekly text messages and refill reminders
- 100-day supply conversion for member if possible
- · Education program led by a pharmacist
- Monthly cholesterol management classes
- Deprescribing

Flu Patient education on importance of getting vaccinated using the SHARF model

- Include messaging in the aftervisit summary
- Provide patients with educational materials to explain the benefits of the flu vaccine and the risk of complications for those at high risk

Ensure classes and educational material are offered in English and Spanish

Ensure providers are bilingual and culturally congruent with their patients

Ensure team members are trained on culturally sensitive care and communication skills

Collect data on language preference and Race

Stratify opportunities and outcomes by language preference and Race
