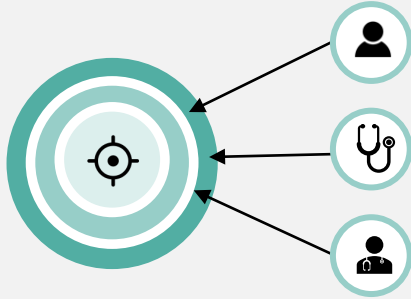

Prioritizing patients with Social Risk Factors as part of the new Health Equity Index

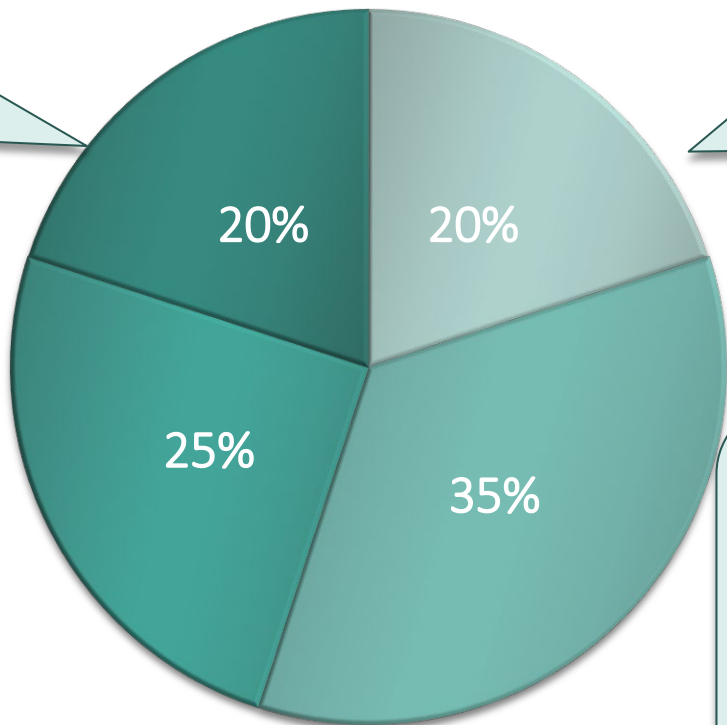

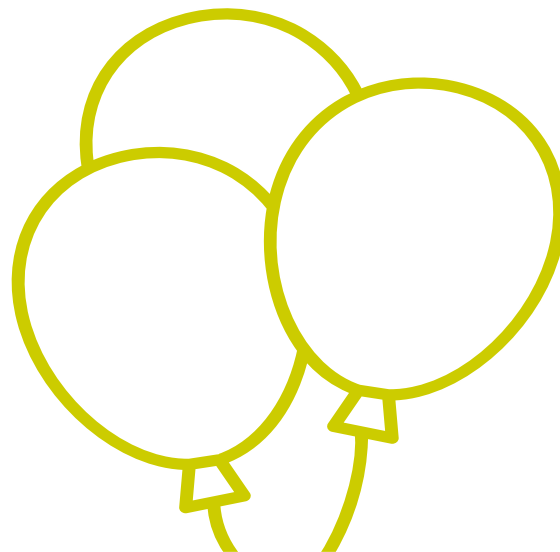
