COMMISSION PAYMENTS

You asked and we delivered.

SCAN is pleased to announce the successful launch of twice-monthly commission payments! It's all part of our commitment to you and your business:

- Commissions will be paid on the 2nd and 17th of the month
- Your payment on the 2nd of the month will include prior month renewals
- AND your commission will now be based on the CMS approval date, not the effective date.

Larger checks

Your June 17th payment included both current and future month new business submissions (June, July, Aug. and Sept.). Your July 2nd payment will include June renewals, plus future effectives.

The fine print: Electronic payments will be delivered same day; mailed checks will take longer.

Commissions will be paid on submissions that have been confirmed by CMS. **Questions?** Email SalesCompensation@SCANHealthPlan.com
